I/We the applicants authorize the RM of Rockwood to establish a Pre-Authorized Payment Plan to initiate quarterly electronic payments to my/our utility account indicated above, for payment of my/our utility bills. We acknowledge that electronic payments will be withdrawn from the bank account provided on either the attached VOID cheque or pre-authorized debit form and withdrawn on the utility bill due date. I / We also authorize the financial institution named above to charge my/our bank account in payment of the utility bill.

I/We acknowledge the right of the RM of Rockwood to cancel my/our participation in the Utility Payment Plan if any debits are not honored by the participant's financial institution. I/We agree to replace the dishonored payment via online bank payment or cash payment within 25 days of the original payment due date. Failure to replace the dishonored payment will result in automatic removal from the RM of Rockwood Utility Payment Plan and that any unpaid utility charges as of the date of termination of participation in the plan are subject to penalties.

Two weeks' written notice is needed if there is a change in the bank information, the applicant is no longer the utility customer, sell the property, or wish to cancel participation in the utility payment plan for any reason. Any **final** utility bill resulting from the sale or rental of the property (or any other reason) will **not** be included in the payment plan.

ALL FINAL Utility Bills must be paid via cash, cheque, or online bank payment on the due date identified. If you purchase a new property within the RM of Rockwood, you are required to reapply to the Utility Pre-authorized Payment Plan with your new Utility Account Number.
